This is a final response to your Freedom of Information (FOIA) request dated June 15, 2011 and submitted to the Department of Homeland Security (DHS). You are seeking:

1. Any list of those federal, state, local, and foreign governmental entities which DHS plans to or may choose to disclose information that is procured through social media monitoring.

2. Any list of those private sector entities which DHS plans to or may choose to disclose information that is procured through social media monitoring.

3. Any records setting out DHS's legal authority to disclose information that is procured through social media monitoring, including memos, communications, and reports.

Your request was received in this office on June 20, 2011.

After a careful search, this office has reviewed and processed one (1) document comprising three (3) pages. Some DHS information has been withheld in accordance with the Freedom of Information Act, (Title 5, U.S.C.552), exemption (b)(6) the disclosure of which could reasonably be expected to constitute a clearly unwarranted invasion of personal privacy.

Your envelope and letter must be clearly marked "Freedom of Information Act Appeal." The implementing Department regulations establish the criteria under which the FOIA is administered.
