5. CLAUSE INCLUSION AND FLOWDOWN

FAR 52.219-9(d)(9) requires that your company provide assurances that it will include the clause at FAR 52.219-8, "Utilization of Small Business Concerns," in all subcontracts that offer further subcontracting opportunities.

FAR 52.219-9(d)(9) also requires that your company agrees in this plan that it will require all subcontractors, except small business concerns, that receive subcontracts in excess of \$500,000 (\$1,000,000 for construction) to adopt a plan complies with the requirements of FAR 52.219-9, "Small Business Subcontracting Plan."

Rapiscan agrees that the clause will be included and that the plans will be reviewed against the minimum requirements for such plans. The acceptability of percentage goals for small, HUBZone small, small disadvantaged, veteran-owned, service-disabled veteran-owned, and women-owned small business concerns will be determined on a case-by-case basis depending on the supplies and services involved, the availability of potential small, HUBZone small, small disadvantaged, veteran-owned, service-disabled veteran-owned, and women-owned small business subcontractors and prior experience. Once the plans are negotiated, approved, and implemented, the plans must be monitored through the submission of periodic reports, including Individual Subcontract Reports and Summary Subcontract Reports through the eSRS website.

In accordance with policy letters published by the Office of Federal Procurement Policy, such assurance must describe the offer's procedures for the review, approval and monitoring for compliance with such subcontracting plans.

6. REPORTING AND COOPERATION

Rapiscan shall comply with FAR 52.219-9(d)(10). Rapiscan shall (1) cooperate in any studies or surveys as may be required, (2) submit periodic reports which show compliance with the subcontracting plan; (3) submit Individual Subcontract Reports and Summary Subcontract Reports through the eSRS website; and (4) ensure that subcontractors agree to submit Individual

7. RECORDKEEPING

Rapiscan shall maintain a database of information regarding prospective and current small business subcontractors. This database shall include the following information:

- Organizations contacted for small, HUBZone small, small disadvantaged, veteran-owned, service-disabled veteran-owned, and women-owned small business sources;
- Records to support other outreach efforts, e.g., contacts with minority and small business trade associations, attendance at small, HUBZone small, minority, veteran-owned, service-disabled veteran-owned, and women-owned small business procurement conference and trade fairs;
- Records to support internal activities to (1) guide and encourage purchasing personnel, e.g., workshops, seminars, training programs, incentive awards; and (2) monitor activities to evaluate compliance.

8. TIMELY PAYMENTS TO SUBCONTRACTORS

Rapiscan has an ISO 9001: 2000 registered business process, and employs standard industry practices for its payments to subcontractors and vendors.

9. DESCRIPTION OF GOOD FAITH EFFORT

Rapiscan intends to make a good faith effort to comply with the subcontracting plan and will make the following efforts:

- Distribute the subcontractor plan to the required stakeholders;
- Establish a new record keeping system to track efforts to identify and retain small business subcontractors;
